### I. CALL TO ORDER

Mr. Dove called the meeting to order at 10:01 a.m. A quorum was present. Mr. Dove welcomed Mr. Andrew Heath, of the GDOT Planning Office, to the committee.

#### **II.** APPROVAL OF SEPTEMBER 14, 2011 MEETING MINUTES

Mr. Dellaria made a motion to approve the minutes of the September 14, 2011 Policy Committee meeting. Mr. Munro seconded the motion. The vote was unanimous.

# III. REVIEW OF PUBLIC COMMENT RECEIVED AT TCC MEETINGS / PLANNING COMMISSION MEETINGS

#### IV. REVIEW AND DETERMINATION OF FINAL AMENDMENT TO FY 2012 – 2015 TRANSPORTATION IMPROVEMENT PROGRAM TO REVISE 5309 TRANSIT FUNDING

Ms. McDuffie reminded the group that this amendment would revise transit funding under the 5309 program. A 15-day public comment period was conducted September 26 – October 10, 2011. There was no public comment received.

Mr. Dellaria made a motion to approve the Final Amendment to the FY 2012 - 2015 TIP to revise the Section 5309 funding. Mr. Heath seconded the motion. The vote was unanimous.

## V. REVIEW AND DETERMINATION OF ADMINISTRATIVE MODIFICATION TO FY 2012 – 2015 TRANSPORTATION IMPROVEMENT PROGRAM TO REVISE FUNDING FOR THE OLYMPIC DRIVE / PETER STREET INTERCHANGE PROJECT

Ms. McDuffie explained that the Georgia Department of Transportation had requested that the cost estimate for the Olympic Drive / Peter Street Interchange project be revised. The construction funding had decreased from approximately \$14.6 million to \$8.7 million. The cost of utilities had increased from approximately \$666,000 to \$2.5 million. As an administrative modification, no public involvement would be required for this action.

Mr. Heath made a motion to approve the administrative modification to the FY 2012 - 2015 Transportation Improvement Program to revise the funding for the Olympic Drive / Peter Street Interchange project. Mr. Munro seconded the motion. The vote was unanimous.

#### VI. OLD BUSINESS

There was no old business to discuss.

#### VII. NEW BUSINESS

Ms. McDuffie thanked the Oconee County staff for their assistance with holding meetings in Watkinsville during 2011.
